Re-opening child care centres

Child care centres across Canada are beginning to re-open and details of opening provisions across provincial and territorial jurisdictions are being released. This table provides an overview of important features such as modified ratios, group sizes, physical space provisions, and additional physical distancing measures. Please note that this is not a fully comprehensive table, as the jurisdictions have provided additional provisions to service providers; the links to further P/T details have been provided in this table where possible.

Re-opening schools

Regulated child care has been officially allowed to reopen in all provinces/territories. Uncertainty about whether and how schools will reopen in September for children in grades K-6, (as well as older children) has become a child care issue as other workplaces reopen and parents contemplate their return to work.

Provinces and territories have or are in the process of announcing return to school plans for September. CRRU has created a chart that provides provincial /territorial policies and procedures relevant to reopening schools in Fall 2020.
