Quebec: Public consultation on educational child care services

This ISSUE file will pull together all elements of the public consultation on educational child care services conducted by the Government of Quebec between April and June 2021. The consultation aimed to identify potential solutions related to the increased and more complex needs of child care services, to improve and ensure equal opportunities for all children and to meet the needs of working parents in Quebec.

The ISSUE file will be broken down into sections: government information, community responses, media and other relevant information.

The ISSUE file has been updated to reflect the adoption of Bill 1, An Act to amend the Educational Childcare Act to improve access to the educational childcare services network and complete its development [1], as a result of the 2021 public consultation.

Adoption of Bill 1

On 7th April 2022, Québec officially passed Bill 1 which amends the *Educational Childcare Services Act*. The new legislation enacts major reforms, including recognizing child care as an entitlement and specifying the government's legal obligation to ensure child care availability where it is needed. In addition, the amended legislation modifies the method of allocating spaces in order to speed up the expansion process by increasing the maximum capacity of child care facilities from 80 to 100 as well as integrating unregulated home child care providers into the network.

Québec's major reforms of child care

Building on the recommendations received in the public consultation on educational child care services earlier this year, the government

of Québec introduced a bill [15] that enacts major reforms to the child care system, including specifying the right of a child to receive educational childcare services as well as the obligation for the Minister of Families in ensuring the development of subsidized child care where there is inadequate supply. The Minister also presented an action plan [16] committing at least three billion dollars (\$1.8B in new spending) to creating 37,000 new subsidized spaces by March 31, 2025 including 1,000 spaces for Indigenous communities. While 19,000 spaces (including 3,500 non-subsidized spaces to be converted) are already underway, the government has launched a call for projects to create the remaining 17,000 spaces. This plan also includes an increase in the child care tax credit. This follows the government's announcement [17] about a raise of 12% to 17% in wages for early childhood educators in publicly funded programs (CPEs) as staff continue to strike and protest across the province amidst negotiations of a new contract.

An Act to amend the Educational Childcare Act to improve access to the educational childcare services network and complete its development [15]

National Assembly of Québec, 2021

The Minister of Families introduced a bill to improve access to the Quebec's educational childcare services network and complete its development. The bill reinforces children's right to receive quality educational childcare services by introducing the obligation for the Minister of Families to ensure the development of subsidized child care where there is inadequate supply. In addition, the bill amends the mechanism for assessing child care needs and assigning new subsidized spaces, repeals the provisions concerning unregulated home-based child care and introduces special rules allowing the Government to enter intro an agreement with an Aboriginal nation or community on any matter within the scope of the Educational Childcare Act or the regulations.

Plan d'action pour compléter le réseau des services de garde éducatifs à l'enfance [16]

Building on the recommendations received in the public consultation on educational child care services in spring 2021, the government of Quebec announced an action plan that aims to improve availability, accessibility, and quality of the existing child care system, consolidate home-based child care services, and strengthen the workforce. The plan also includes proposed legislative changes that will enact major reforms to the publicly funded system and give the government special powers to fill necessary gaps in the system, like creating new subsidized spaces and monitoring the waiting list.

L'Association québécoise des centres de la petite enfance (AQCPE) welcomes the government of Quebec's action plan to complete the network of educational childcare services. The AQCPE and its member expect that a large majority of the development projects will be in CPEs to meet the need for quality child care expansion. The association notes that targeted resources and collaboration between various stakeholders are required to improve accessibility to vulnerable children. The AQCPE also support the government's intent to move towards a fully regulated family child care system. Finally, the AQCPE emphasizes that quality child care must be accompanied by qualified staff and on-going professional development in both centre- and home-based child care.

L'Association québécoise des centres de la petite enfance (AQCPE) presents its recommendations as part of the Quebec consultation on educational childcare services. The report emphasizes that Quebec must officially recognize the right of all children to quality early childhood educational services on a non-mandatory basis. It also highlights that parent preferences and quality research all point to the model of centres de la petite enfance (CPE) and family child care which are regulated and subsidized.

The Collectif petite enfance presents their recommendations regarding the barriers for families in general, and vulnerable families in particular, to access early childhood education services. Collectif petite enfance emphasizes on systemic barriers, more specifically the lack of collaboration between different government levels, between ministries and also between services.

La Fédération québécoise des municipalités (FQM) recommends in particular facilitating the issuance of permits to projects supported by the community and municipality with the aim of granting greater flexibility and agility to the network. The Federation also emphasizes that up-to-date and precise data must be used to guide the development of new child care services where there are the needs. The report also calls for the establishment of a national committee to review the process of allocating and developing child care spaces in order to respond more quickly to the changing needs of the communities.

La Directrice régionale de santé publique (DRSP) de Montréal presents their recommendations to improve child care services in Montreal and in Quebec as a whole. Key recommendations include: prioritize access to CPEs for children from low-income families and those having developmental challenges; support the partnership between child care services and integrated university health and social services centres; and reduce structural barriers to the development of CPEs through engaging municipalities and districts to integrate the development of child care centres in urban planning.

The report by the Fédération québécoise des organismes communautaires du Québec (FQOCF) brings attention to solutions to increase access for families in vulnerable situations to drop-in centres (halte-garderies) and to various child care services. The recommendations also address non-standard care, networking between local organizations, workforce presence in the advisory committees, current lack of spaces and child care labour shortage.

In its report, the Fédération des chambres de commerce du Québec (FCCQ) highlights that a thorough assessment of child care space coverage rate is crucial to address the shortage of child care spaces and its impact to the vitality and competitiveness of industries. The recommendations also mention the need to establish flexible hour child care to support workers with non-standard hours. In addition, the FCCQ includes recommendations regarding supporting the child care workforce and updating the salary scale, reducing administrative delays in building new child care centres, and use of federal transfer to ensure workers' access to affordable and quality child care services.
