Issues in for-profit and not-for-profit childcare

Introduction

The following resources are pertinent to the issue of auspice (used here to mean for-profit or not-for-profit status) in early learning and child care in Canada. Materials are organized by their main topic, with further division into Canadian and international documents. Finally, materials pertaining to two case studies are provided (Australia and the United States). These sections feature research and analysis on the issue of auspice in those countries as well as a selection of related news articles.

Each section features both documents available in full-text online and/or in print from the Childcare Resource and Research Unit's resource collection.
